## User's Consent personal data processing

Pursuant to Articles 23, 24 of the Constitution of the Russian Federation, Federal Law dated 27.07.2006 No. 152-FZ "On Personal Data", the Policy on Personal Data Processing posted on the website <a href="https://inetstudio.ru">https://inet.studio/pdf/personal-data-processing-policy-en.pdf</a> (hereinafter referred to as the Policy on Personal Data Processing),

I, the subject of personal data, hereinafter referred to as the User, by sending information through feedback forms (hereinafter, each of them and all of them in the aggregate-Forms, Forms) for the purposes of using the website https://inetstudio.ru and its services (hereinafter referred to as the Website, Service), and further when using the Website and/or its Services, express my full, unconditional and unambiguous Consent to the processing of my personal data (hereinafter referred to as the Consent) on the following terms and conditions:

- 1. The Consent has been issued to Ainet Production Limited Liability Company (Ainet Production LLC, INN 7730241900, OGRN 1187746242353), located at the address: 121059, Moscow, 16 Berezhkovskaya Nab. 2 (hereinafter referred to as the Operator).
- 2. Consent is given for the processing of personal and other data provided by the User in the Forms by filling in the relevant text fields and/or files attached to the Forms, namely the following categories:
- surname, first name, patronymic, e-mail address (e-mail), telephone number, other similar information provided by the User of the Website, on the basis of which his/her identification as a subject of personal data is possible.
- data that are automatically transmitted in the process of browsing and visiting the pages of the Site: IP address, information from cookies, browser information, access time, address of the visited page, referrer (address of the previous page);
  - statistics on my IP addresses.

## 3. Consent has been given for the processing of personal data for the purposes of:

- identification when registering on the Site and/or using the Service;
- providing services, processing requests and applications;
- establishing feedback, including notifications and inquiries;
- collection of statistics by the Operator;
- improving the quality of the Website and/or its Service, their usability and the development of new services and facilities;
- marketing (advertising) activities, sending offers by the Operator and receiving them by the User to promote the Operator's services on the market, including through direct contacts.

The User hereby confirms, is aware and agrees that for the above purposes, the Operator has the right to collect and use additional information related to the User, obtained during the User's access to the Site, its Content and/or Service, or from third parties, and including data on technical means (including mobile devices) and methods of technological interaction with the Site and/or its Service (including host IP address, type of operating system of the User, type of browser, geographical location, data on the User's access to the Site and/or its Service, etc.).

4. Consent is given for processing personal data in a mixed (automated and non-automated) manner.

In the process of personal data processing the Operator has the right to collect, record, systematize, accumulate, store, clarify (update, change), extract, use, transfer (distribution, provision, access), depersonalize, block, delete, destroy the User's personal data.

- 5. The User hereby acknowledges that:
- **5.1.** Gives consent to the processing of his/her personal data specified in paragraph 2 of this consent to the persons specified in paragraph 1 of this consent, as well as confirms that the Operator has explained the consequences of failure to provide personal data, in cases where the provision of such data is mandatory in accordance with federal law.
- **5.2. Informed of the possibility to withdraw the consent** on the basis of the provisions of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data" by personal application or by sending a

written application (including in the form of an electronic document signed with a simple electronic signature or an enhanced qualified electronic signature) to the persons indicated in paragraph 1 of the Consent, including informed of the right to withdraw the Consent in order to stop processing by the person indicated in paragraph 1 of the Consent as all the personal data indicated in paragraph 2 of the Consent.

- **5.3.** I am informed that the persons specified in paragraph 1 of this Consent have the right to continue processing of the User's personal data after receiving the revocation of the Consent, as well as after the expiration of the Consent, if there are grounds provided for in Article 9, paragraph 2 of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data".
- **5.4. Agrees to receive advertising** and **informational materials and is** familiarized by the Operator with the possibility and procedure for refusal of such.
- 6. The consent comes into force from the moment of its sending and can be withdrawn by the User by sending a written application in any form to the Operator to the e-mail address director@inetstudio.ru or in any other way that allows to unambiguously determine the fact of its receipt by the addressee.
- 7. The Consent is valid for an indefinite period of time until revoked by the User. The Consent shall terminate from the date specified in the User's application for withdrawal of the Consent to process Personal Data, but not earlier than the date following the date of actual receipt of the withdrawal of the Consent by the Operator.
- **8.** The date and time of formation, confirmation and sending of the Consent shall be considered the moment of marking the corresponding field (or clicking on the corresponding button) in the Form and/or clicking on the button of sending the Form on any page of the Site and/or its Service.
- 9. Guided by part. 4, Article 9 of the Federal Law of 27.07.2006 № 152-FZ "On Personal Data", I send my personal data through my personal mobile device or personal computer by attaching it to a special form or by filling in the appropriate fields of such form when registering on the Site.
- 10. The User is informed that the responsibility before him/her for the actions of the person processing his/her personal data on behalf of the Operator shall be borne by the Operator who issued the relevant instruction (consent).
